Overview

The Traveller Movement 2024 conference, 'An Era of Change' will celebrate the beginning of a new chapter and will explore innovative policies that can bring about substantial improvements in the lives of these communities. While the challenges we face loom ever large now is the moment to chart a new path and call upon decision makers to break down barriers for Romani (Gypsy), Roma and Irish Traveller communities to bring about a new dawn.

Romani (Gypsy), Roma and Irish Traveller communities face multiple interconnecting disadvantages which have worsened since the Covid-19 pandemic and the ensuing cost-of-living crisis. Poor access to services, lack of access to adequate education, over-policing, overrepresentation in the criminal justice system, and an unfolding mental health crisis are among the barriers these communities face. Coupled with the persistent discrimination faced by the communities across every facet of their lives there is no doubt that Romani (Gypsy), Roma and Irish Traveller communities face systemic challenges in the UK.

The communities also face chronic democratic underrepresentation, with their inequalities often ignored by policymakers and labelled as unimportant. Often left out of conversations about systemic racial discrimination and pushed to the side in broader equality and improvement initiatives, their unique challenges and needs remain unmet.

But with a new Government comes a new opportunity for policymakers and community members to the table to collaborate on revolutionary policies which will break down barriers which have long held communities back. Only with innovative policy solutions can the multiple, interconnecting crises facing Romani (Gypsy), Roma and Irish Traveller communities be tackled.

To address these challenges and bring about bold new ideas, the 2024 Traveller Movement Conference will bring together Romani (Gypsy), Roma and Irish Traveller community members, campaigners, policymakers, and other stakeholders to lead the way towards the new dawn of policymaking for Romani (Gypsy), Roma and Irish Traveller communities.

Through panels and workshops we will bring together changemakers and passionate advocates to bring about 'An Era of Change'.

The Traveller Movements Operation Traveller Vote campaign highlighted how powerful the communities' voices can be when they are combined for one goal; change. This year our conference will aim to channel those voices to tackle years of structural and institutional failings by revolutionising the policy landscape with new and creative ideas.

In this workshop, we want to harness the powerful voices of inspirational Romani (Gypsy), Roma and Irish Traveller women and ask them, in this era of change, what are the next steps we need to take to advance gender equality for women and girls?

In answering this question, this workshop will explore the value of role models, the importance of building one another up and the actions the government must take to support a community-led definition of empowerment and gender equality.

Keynote Speaker: Jacob Sakil

At the age of 16, **Jacob Sakil** was elected for a year's tenure as Young Mayor of Lewisham. Since 2017 he has followed a career in Youth Work sharing his passion about ensuring children and young adults have an accessible and transparent avenue to engage in local democracy and civic life. Jacob is also the founder of American Bites start-up, Youth Justice Service representative and sits on the Business in the Community's (BITC) Place Taskforce supporting the collaborative potential of business to strengthen communities around the UK.

Dr Debbie Weekes-Bernard chairs the Mayor's Equality, Diversity and Inclusion Advisory group, as well as London's Strategic Migration Panel and is co-chair of the Diversity in the Public Realm Commission. She is also a member of the TUC Anti-Racism Taskforce and the World Economic Forum Global Future Council on Systemic Inequalities and Social Cohesion. Debbie worked at the Runnymede Trust as Head of Research, running their work on inclusive curriculum development, education attainment gaps and school exclusion as well as work on community cohesion, race and criminal justice and youth transitions. She also worked as a Lecturer of Social Psychology and Criminology, teaching students in both the further and higher education sectors.

Dr Thomas McCann is a member of the Irish Traveller community, a longstanding activist for Traveller rights and a founder of Minceir Misli, the first Traveller-only organisation.

Thomas has been employed as the Equality worker and as a Director in the Irish
Traveller movement, where he campaigned for crucial legislative acts, such as,
the Equal Status Act, the Traveller Accommodation Act and recognition of Travellers as
an Ethnic group. Thomas holds a Diploma in Community Development, a BSc in
Psychotherapy and MSc in Counselling Supervision and Doctrate in Social Studies,
Thomas serves on the National Traveller and Roma Inclusion Strategy Committee and is

also a member of the Council of Europe's Framework Convention on the Protection of National Minorities. Thomas established and currently manages the Traveller Counselling Service which was launched in 2008.

Simon Hood supports numerous major projects across the Runnymede Trust's research portfolio. He has research expertise across race and migration, criminal justice and the cultural sector. Simon is the co-author of 'Confronting Injustice: Racism and the Environmental Emergency', 'Visualise: Race and Inclusion in Art Education' and 'Racial Segregation and the Asylum System'. He is currently leading the development of new research relating to Traveller and Roma communities within Runnymede.

Over the years, **Mick Cash** has carved a career in the rail industry, engaging actively in the NUR, later the RMT, where he eventually became Senior Assistant General Secretary. Elected as General Secretary in 2014 after the passing of Bob Crow, he worked extensively in the rail sector and sat on the Labour Party NEC. Concurrently, he served as a Labour Councillor in Watford until 2002. Retiring as RMT General Secretary in May 2021, he remained involved as Trustee Director of the Railway Pension Scheme, non-executive director of Railpen, and trustee of the Railway Benefit Fund charity. Mick is very proud of his Irish Traveller Heritage.

Jeffrey Greenidge is an experienced teacher, coach and leadership mentor who has worked across the education and training sector. His career in education began as a teacher of modern languages and physical education. This was followed by a three-year tenure as Head of Modern Languages at Llanrumney High School in Cardiff, before he joined the Curriculum and Assessment Authority for Wales, advising the Government on matters relating to language teaching and learning. Jeff joined the Board of Governors at Bridgend College in January 2021 and became Chair in December of the same year. During his tenure, Jeff oversaw the College's most recent Estyn inspection, which highlighted the strong, supportive and inclusive culture for learners and staff.

John McCarthy is an Irish Traveller and has been a Trustee of the Traveller Movement for many years. Prior to that John was on several boards of management with national and local Traveller groups in Ireland. John is a qualified Social Care Worker having obtained a BA Honours degree in Social Studies Trinity College Dublin. John is currently work in the caring profession supporting adults with learning disabilities and mental health issues in a community setting.

Betty (Elizabeth) Smith-Billington BEM, is a proud Romany Gypsy who has campaigned for many years for the rights of all Travellers. Betty is CEO for the Kushti Bok charity which acts as a voice for the Travelling communities in Dorset and beyond. As well as that Betty is vice chair of Dorset Council G&T Forum. She has attended TM conference for many years and has been honoured to work with them over the years. She has gathered many awards (over the years) in Dorset including "Women of Impact" and "Women's Achievement". Betty was the first to achieve the Susan Alexander Lifetime achievement award from FFT.

Patrick O'Leary is a proud Irish Traveller man from West Meath, Ireland, and an advocate for the rights of his community. In 2000, he played a crucial role in securing ethnic minority status for Irish Travellers in the UK, marking a significant victory against discrimination. As a proud father, grandfather and great-grandfather, Patrick has encouraged his family to take pride in their heritage and continue the fight for Traveller rights. His dedication to justice and equality has left a lasting impact, with his family following in his footsteps to gain respect and recognition for the Irish Traveller community.

Lourdes Marie Green is an Irish Traveller and the Women's Research & Development Officer at the Traveller Movement. Coming from a family of advocates, her mother and many relatives also worked at the Traveller Movement over the years, while her Grandfather played a key role in gaining ethnic recognition for Travellers. Lourdes was one of the first in her family to complete high school and sixth form, and the first to attend university, where she graduated with a first class degree in Law and Criminology from Roehampton University. She aspires to pursue a career in law and hopes to one day become a solicitor advocating for Romani (Gypsy), Roma and Irish Travellers.

Charlie Doherty is a young Irish Traveller from London. He left school at 11 to work in the family business, but then returned to education at the age of 19, starting an access course in business studies. Alongside his studies, he also became an Intern with the Traveller Movement moving up to the position of Youth Engagement and Development Officer. Charlie is a member of the TM's Advisory Group and has recently started University life.

Olivia Morrison is the Head of Partnerships and Advocacy and joined the team in January this year. She is of Romani (Gypsy) heritage, with strong family ties to South London. Olivia began her career in the non-profit sector in Stockholm, Sweden after graduating from the University of Edinburgh with an MSc in International Development. Having worked for several years within the grant management sector, she decided to pursue her passion campaigning for the rights of Romani (Gypsy), Roma and Irish Traveller communities and undertake a new challenge at The Traveller Movement.



Sarah Dunne has recently joined the TM team as the Advocacy and Campaigns Officer. Sarah, from Ireland is also an Irish Traditional musician, and singer who learned the traditional Irish Traveller style of music and song from her Father, the very famous Pecker Dunne. She moved to the UK ten years ago to begin her career in teaching, after completing her Masters Degree at Trinity College Dublin.
